Fulfilling Lives South East Multiple and Complex Needs Project

The National Lottery Community Fund is supporting people with complex needs in 12 areas of England, with a national investment of £112m.

The purpose of the Fulfilling Lives project is to bring about lasting change in how services work with people with multiple and complex needs. For the purpose of this project, complex needs is defined as having complex combinations of issues including substance misuse, poor mental health, homelessness and offending.

The aim of the project is to lead change for more effective, efficient and better co-ordinated services for people with multiple and complex needs and to pilot and evaluate the impact of delivering better connected services to inform future policy and commissioning. The project operates in Brighton and Hove, Eastbourne and Hastings.

BHT is the lead organisation for the South East Partnership. The project is supported by a Core Group of voluntary and statutory sector partners.

Salary

The salary is paid monthly in arrears and will be £27,218 per annum. A 5.5% employer's pension contribution is also paid. The level of this contribution is reviewed annually.

Hours of Work

The hours of work will be 37 hours per week, working predominantly Monday to Friday 9:00am to 5:00pm, however the ability to work outside of these hours (evenings or weekends) as and when required is necessary. BHT does not pay overtime but will grant "time off in lieu" when agreed by the Project Manager.
