

Job Summary

To provide residential and housing related care and support using a person-centred, recovery-based approach for vulnerable adults with mental health and complex support needs across the integrated project.

To ensure that tenancies are sustained, and a range of needs are met such as access to mental health, substance use and other health services, general practical help, assistance with welfare benefits, budgeting, life skills, emotional/wellbeing support, promoting health, independence and quality of life and encouraging residents to participate in the wider community.

Duties / Responsibilities

Client Support

To provide the necessary emotional and practical support to clients. This includes:-

- Working with clients in either of the houses in the project, sometimes independently of immediate management support.
- 2. To develop good working relationships with clients and carry out key working responsibilities for a small caseload.

3. To assess the needs and risks for each client and develop an individual, co-produced and person-centred plan that identifies strengths and resources for clients to make choices and gain control of their lives.

- 4. Encouraging and supporting clients in all matters of personal hygiene and care, according to their individual Support Plans.
- 5. Supporting clients in developing life skills including self-care, shopping, cooking and laundering.
- 6. Organising and participating in social activities and supporting clients in accessing the wider community.
- 7. Ensuring that client's rights are protected and acting as advocate for the client.
- 8. Ensuring that the licence agreement, house rules, policies and procedures are followed.
- 9. Providing appropriate welfare benefits advice to clients.
- 10. Gathering, recording and utilising information using appropriate information technology; keeping respectful and objective case notes.

Household

To assist in the efficient domestic running of the house. This includes:-

- 11. Participating in shopping or arranging for food and supplies to be bought.
- 12. Participating in cleaning or ensuring that cleaning is carried out.
- 13. Participating in cooking or ensuring that meals are cooked.
- 14. Monitor maintenance and repair issues and report to the Tenancy Centre.
- 15. Monitor and report health and safety issues.

Administration

To carry out the necessary administration. This includes:-

- 16. Ensuring that records are kept up-to-date and accurate and an efficient filing system maintained including the use of appropriate information technology.
- 17. Writing reports on clients or ex-clients as required.
- 18. Assisting in the collection of weekly charges.
- 19. Processing and recording all income and expenditure.
- 20. Administering and recording medication.

General Tasks

21. To participate in a work rota which will include late shifts; sleep-in duties; weekend work.

- 22. To visit clients and prospective clients in hospital, and to keywork where appropriate with prospective clients.
- 23. To attend and engage in regular line management supervision.
- 24. To assist in the supervision of volunteers, interns and students where required.
- 25. To attend and participate in staff meetings, reflective practice, and other meetings as appropriate.
- 26. To have a working knowledge of issues related to Mental Health and apply best practice, including the use of Psychologically Informed Practice and Co-Production.
- 27. In conjunction with the Manager, to ensure that his/her/their personal training needs are met.
