BHT Sussex BHT Sussex is a charity and a registered housing association working in Brighton and Hove, Eastbourne, Hastings and other parts of Sussex. BHT Sussex's Mission is to combat homelessness, create opportunities, and promote change and aims to achieve this Mission through a network of interlinked projects. By providing direct, practical services combined with a commitment to challenge the causes of poverty and inequality, we hope to achieve a supportive structure which people can use in a variety of ways to improve the quality of their lives.

#### **Service Details**

The Homes for Ukraine scheme enables British citizens to sponsor and host Ukrainians in their homes.

Our Sustainment Service provides support for hosts and Ukrainian guests to help prevent the breakdown of sponsorship arrangements as well as to move on to independence when the time is right.

The aim is to sustain placements, as well as support Ukrainian guests to access health and community services, and employment and educational opportunities. This will help guests to live independently when they leave the host accommodation.

In addition to this, we deliver/co-deliver workshops, webinars and written guides to support hosts and guests to plan for when guests move on, and we provide support to identify suitable accommodation and employment support at the end of the hosting arrangement, working alongside partner organisations to this end.

As the strategic partner with East Sussex County Council (ESCC) for homeless prevention, we have developed this new provision with them as part of ESCC's countywide response for people fleeing Ukraine.

# **Job Summary**

The Workshop Coordinator will:

- Devise, develop and deliver/co-deliver a rolling programme of workshops and webinars relating to information, guidance and support for Ukrainian people living in East Sussex.
- Create easy-read information guides in partnership with voluntary and statutory partners.
- Liaise with landlords and letting agents to identify potential barriers for Ukrainian tenants.
- Build mutually beneficial relationships with partner organisations in the sector to enhance opportunities for clients.

- Work closely with the rest of the HFUSS team in order to establish and provide support tailored to the needs of the clients.
- Work with individual people/families on specific issues.
- Work creatively and flexibly in partnership with clients in a person-centred manner.
- Use psychologically informed ways of working to gain a greater understanding of the challenges and barriers faced by people new to UK.

## Salary

Salary is paid monthly in arrears and will be £24,547 pro rata per annum plus a user car allowance of £1,218 pro rata per annum. An employer's pension contribution of 5.5% is also paid. The level of this contribution is reviewed annually.

## **Hours of Work**
